Thank you for the opportunity to respond to MS Australia's federal election priorities.

Roadmap 1: Defeat Multiple Sclerosis in Australia

The Australian Greens support efforts to defeat multiple sclerosis in Australia. A key element of health platform is a focus on prevention, and of treating health as an investment, not a cost. We will ensure that all Australians, including those with MS, have access to the best possible models of care from the onset of their symptoms through to ongoing treatment and management. Our specific health policies will be released later this month, and we look forward to discussing these with you.

Roadmap 2: Support people with MS Living with Disability

The Australian Greens are committed to the timely and full roll out of the National Disability Insurance Scheme (NDIS). We recognise the substantial impact the NDIS will have on the lives of millions of Australians who require support and will maintain our vocal advocacy for its swift and effective implementation. The Australian Greens agree that those with a disability should access the services which best meet their needs and that both NDIS and Australia's aged care system should be appropriately resourced.

The Greens hold serious concerns about younger people in residential care, with Greens Senator Rachel Siewert Chairing the 2015 Senate inquiry into this issue. The Greens continue to urge the government to implement in full the recommendations of that inquiry, which would greatly reduce the need for young people to receive care in these facilities. Roadmap 3: Support people Ageing with MS

Our vision is for older Australians to be able to continue to participate fully in their communities and have their skills, life experience and contributions recognised.
