

## Privacy Collection Statement – Donors

Multiple Sclerosis Australia (ACN 008 515 508) (**MS Australia**) is committed to protecting the privacy of individuals and their personal information and complies with the *Privacy Act 1988* (Cth) (**Privacy Act**).

Please read this carefully as it will have important consequences for you in relation to the collection, use and disclosure of your personal information provided to Australia.

You understand that:

1. MS Australia is the party who is collecting your personal information and can be contacted at [info@msaustralia.org.au](mailto:info@msaustralia.org.au) or alternatively you can write to us at PO Box 625, North Sydney, NSW 2059.
2. MS Australia will collect your personal information directly from you. In certain circumstances, MS Australia may be required to collect personal information from third parties, depending on the nature of your donation.
3. The purpose of MS Australia collecting your personal information is:
  - (a) to process any donation you make to MS Australia contact you and provide you with information in relation to your donation;
  - (b) for payment processing, including charging, refunds (if applicable), credit card authorisation and verification;
  - (c) to administer MS Australia's various donation and fundraising programs, and associated initiatives, such as maintaining donor databases and donor correspondence; and
  - (d) to offer you updates, discounts, or other content or products and services that may be of interest to you and to provide you with direct marketing communications from us or our related entities and associates (using direct mail, telemarketing, email, SMS and MMS messages),

and you acknowledge and agree to your personal information being collected and used for, and in connection with, these purposes and any other purpose described in our Privacy Policy.

4. If we do not collect this personal information in connection with the purposes in paragraph 3, then:
  - (a) MS Australia will be unable to process your donation or supply you with information in relation to your donation; and
  - (b) we will be unable to send you direct marketing communications (unless you have consented to such communications through your other dealings with MS Australia).
5. Your personal information may be disclosed to the following classes of people and organisations in connection with the purposes in paragraph 3:
  - (a) MS Australia, its personnel and any related entities or state-based member organisations;
  - (b) MS Australia's contractors, agents and third party providers who undertake billing and credit services on our behalf;
  - (c) third party service providers including without limitation marketing service providers, IT service providers, contractors and sales consultants and other parties who assist us in providing our services to you;
  - (d) third parties, such as external debt recovery agents, court or other entities to which we are required by law to disclose personal information; and
  - (e) any other organisation as expressly covered in our Privacy Policy.
6. It is possible that some of the information collected may be disclosed to MS Australia's related body corporate or service providers outside of Australia. You **consent** to your information being disclosed to a destination outside Australia for this purpose, including but not limited to the United States of America and you understand and acknowledge that Australian Privacy Principle 8.1 will not apply to such disclosures of your personal information.
7. MS Australia's Privacy Policy sets out the process as to how you can access and correct any of your personal information collected under this form as well as to how you can make a complaint if MS Australia has breached the Privacy Act in the handling of your personal information.
